### ELIGIBILITY CRITERIA:

Candidates must be able to evidence the following criteria:

- 1. Competent and substantive Wholetime Duty System Watch Manager **OR** Station Manager employed in a UK local authority Fire and Rescue Service.
- 2. Middle Manager Technical Test Examination pass from South Wales Fire & Rescue Service **OR** Institute of Fire Engineering (IFE) Level 4 Certificate in Fire Service Operations and Incident Command **OR** Equivalent.
- 3. Skills for Justice Level 4 Award (ICL2) Intermediate Incident Command pass **OR** willingness to participate in an ICL2 assessment as part of the selection process and a commitment to passing the full ICL2 within 6 months of commencement of a Station Manager appointment.
- 4. Minimum of 12 months experience as a Supervisory Manager at an operational station gaining watch leadership and incident command exposure.
- 5. Demonstration of suitable experience of learning within a leadership and management field at Middle Manager level (for internal candidates this can be evidenced from a 'Leading the Function' Pathway) OR a commitment to complete a leadership pathway within 6 months of commencement of a Station Manager appointment and prior to submission of a Development to Competent portfolio.

- 1. **Eligibility** Please outline how you meet the eligibility criteria requirements for this role.
- 2. **Personal Impact -** Please outline how you have created a culture where individual and team wellbeing is a priority and where you have systems in place to make sure teams you lead are coping.
- 3. **Outstanding Leadership** Please outline how you value your team and how you make the best of their diverse skills and strengths.
- 4. Service Delivery Please outline how you have developed and implemented thoughtful solutions or recommendations based on sound evidence and feedback from internal and external sources.
- 5. **Organisational Effectiveness** Please outline how you encourage and respond to being challenged and how you show you are willing to adapt thinking with new information or better evidence.

All documentation is available in both Welsh and English and we welcome communication in either language. Applications submitted in Welsh will not be treated less favourably. Candidates successful at the shortlisting stage will be given the opportunity to confirm their language preference for interviews and assessments (including paperwork, verbal introductions, and interview questions). Arrangements will be confirmed following invitation to interview and may include Translation and/or Simultaneous Translation.
